Lawmakers gave us their word they would make the PRO Act a top priority. It's time for them to keep that promise.

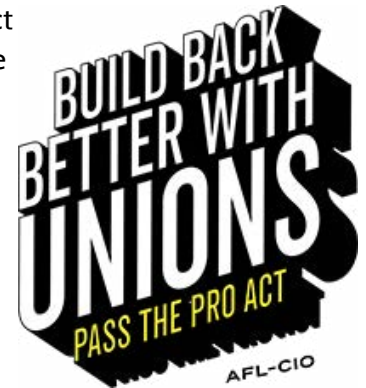
[The PRO Act](#) is the cornerstone of the AFL-CIO's Workers First Agenda
