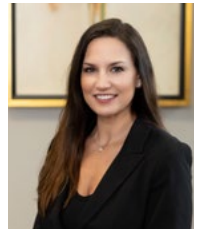

Meet *Dana Apple*.

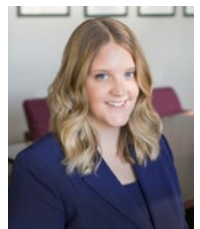

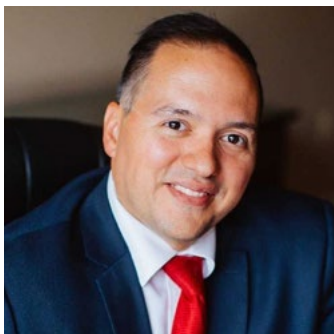
She is licensed to practice law in both Missouri and Kansas and is a member of the Association for Women Lawyers.
